The Neuropathy Action Foundation (NAF), a 501(c)(3) non profit, is dedicated to ensuring neuropathy patients obtain the necessary resources, information and tools to access individualized treatment to improve their quality of life. The entire event will be held at the Sheraton Grand Hotel in Sacramento, California - a perfect location for patients attending from all over the U.S.

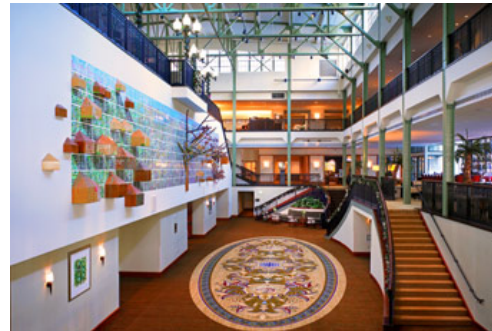
